**Texas Lions Camp – PDG John Paul Burnett –** Registration on the TLC website will open January 2, 2020. Sponsoring Lions need to go on the website to sign up before sending in applications. The Camp Bus will run the 1<sup>st</sup> and 5<sup>th</sup> Sessions. We can take 30 kids on the bus.

**TLC Directors – Robert Duckworth** requested help for Camp work weekends. PTLCP Rick Stoorza announced a Golf Tournament in August that needs support from District 2E2.

**LOEB – Emily Rohne:** Coordinated equipment and hours. Lions vision screenings totaled 203 for a total of 960 hours. Children screened were 7,126, Burleson had 4,700 kids. The LOEB website has been updated. We need board and committee members to attend the April 25<sup>th</sup> Garden of Life Event. (See Attachment 8 for Full Report.)

**JC Hyer – Terry Bailey** reported they capped at 25 students this year in the 17 – 19 age range. They will be here between June 27 and August 2. They would like Lions to attend events as a Club to interface with these young adults. She offered thanks to District 2E2 for changing the world one heart at a time through kids.

Princeton

The Angel Tree program, which is sponsored by the Princeton Lions Club, is closing in on a half million dollars in charitable contributions to the community since its inception 12 years ago.

What initially started through the PISD transportation department as the "Fill the Bus" initiative has evolved into a massive communitywide effort that assisted 607 students and 208 families this year alone.

"There are so many people who played a significant role in this effort," Lions Club president Rene Mullins said. "But our students and teachers are really the ones who work hard to give back to the community. They adopt angels and shop together. They organize the food drives and help sort. They are amazing. The Princeton Lions Club would like to thank all the teachers, student organizations, teams and community volunteers that helped with this year's Angel Tree. They made all this possible."

Lions Club member and Superintendent Philip Anthony pointed out that teachers contributed a bulk of the funds needed this year through employee payroll deductions, and the band program once again took up collections at the recent Christmas concerts.

The food drive also reached epic proportions this year as 21,343 items were donated to the holiday effort. Lacy Elementary collected the most food, followed by Harper and Lowe.

"Our ministerial alliance here really comes together for food drive effort, as well." Mrs. Mullins said. "The Lions Club has the support of a lot of great volunteers, and we couldn't do this without them."

Lacy Elementary won the prize for most food drive donations, with 5,274 items, while Harper collected 3,729 and Lowe had donations of 2,657.

PISD has a number of students that might go without Christmas if the Lions Club and its members did not reach out to them. This marks the 12th year that the program was able to assist every applicant.

"I'm proud of the fact that we have always been able to take care of 100 percent of the children who applied and qualified for the Angel Tree program," Mr. Anthony said. "This is a testament to the generosity of our community. We had an outpouring of people who stepped up like never before."

Local businesses do their part to make this tradition a success. Several locations, including Independent Financial, First Bank and Trust, the City of Princeton and the Princeton Chamber of Commerce, host Angel Trees on site to help spark adoptions.

And Walmart continued its community support by offering a 10 percent discount to the school district to assist when shopping for angels with the money donated to the Lions Club program.

#### Fundraising

We just completed our Girl's Basketball Tournament (December 6, 7, 8) and Boy's Basketball Tournament (December 12, 13, 14).

Girls – 30 teams – Varsity/JV/Freshman

Boys – 18 teams – Varsity

Our major fundraiser is selling advertising in our basketball program (copy enclosed). Approximately 60% of our revenue comes from the program, the remainder from concessions and admissions. Our total revenues of approximately \$36,000 exceeded last year, but we won't know the bottom line until Glen Rose ISD bills us for the costs of officiating, scorekeeping, etc.

Our other fundraising is our Golf Tournament that is held in early May. The financial results of our Golf Tournament have declined in recent years. The major problem being in a small town such as Glen Rose, every business of any size is asked to support 12 -15 golf tournaments throughout the year. Hence, the gold/silver sponsorships have declined and been replaced by individual entries.

#### Membership

Our membership at 12/31/19 was 46, and holds relatively steady at that number. Growth is difficult, especially trying to attract working age individuals. We have a high percentage of members that are retired.

## World Services for the Blind (WSB) Report

WSB is an organization based in Little Rock, Arkansas that seeks to provide those with low or no vision, "sustainable independence" (mobility. Life skills, Job skills, etc.). The poster child for WSB is their CEO and Pres., Sharon Giovinazzo (in my view).

The Capital Campaign, kicked off in the fall of 2018, is raising funds to replace/repair HVAC systems on the WSB campus. These systems are over 70 years old and badly in need of replacement or updates. Of the \$3.3M goal (updated from 2.2M). Over \$2.2M has been pledged including a \$600K maybe grant just identified, and thus, the campaign needs another \$1.1M.

WSB held their annual Vision Award luncheon, on October 30<sup>th</sup>, a fundraiser that was deemed a success (>\$75K).

Pres and CEO Sharon Giovinazzo and Jim Coleman, Chairman of the Board of WSB, would much appreciate any donations that Lions or Lions clubs or anyone can provide to the Capital Campaign or general budget.

In 2018-19, MD2 contributed over \$28K, down from \$37K in 17-18. So far in 2019-20, MD2 has contributed over 28K, which is almost double the amount from last year. PDG Jim Coleman our new Chairman of the Board and myself the MD2 WSB Chair are taking full credit for the increase.

We are organizing an awareness (fundraising) tour of MD2 & 2E2 by our WSB CEO, Sharon Giovinazzo, during the first week of April. These plans are tentative, but please let me know if your club would like to have a presentation by our CEO.

WSB has begun publishing a newsletter with the first addition out on Jan 03. I have also received an economic update report from our CEO (for those who like numbers) (copies enclosed). Among others, one-point worth noting is that while 70% of visually impaired are unemployed, some 85% of those who complete a vocational program at WSB end up being placed.

If you want to learn more about WSB, I would also be happy to provide a program for your club.

1. On November 12, 2019, I spoke about diabetes awareness at the Azle Lions Club.

## Vision Preservation, Awareness and Action Committee

The **District VPAA** (Vision Preservation, Awareness and Action) **Committee** is tasked to provide Lions in District 2E2 with information, education and direction addressing vision needs in our community. An initial meeting was held in July with our District Governor, Vince Rosen, and the president of the Lions Organ and Eye Bank, Emily Rohne, to determine the scope of the VPAA's activities.

The VPAA will work in conjunction with the Lions Organ and Eye Bank, Community Eye Clinic, Essilor Vision Foundation, North Texas Eye Research Institute, Prevent Blindness Texas and other service groups to create a comprehensive resource guide that Lions can use in their communities. The resource guide will provide the contact information of service providers, their guidelines and type of services. This information will guide local Lions to get the services to those in need. Each local Lions Club should also build a local network of medical providers and contacts so that they can guide people to the most appropriate vision service.

The VPAA will also provide and distribute to the district educational information about sight, medical conditions and testing. This will also include updates on the *Transplant Services Center* and the impact that donations make in our community. This information will help the Lions in District 2E2 to be informed about eye sight and to share this information with their local community as Knights for Sight.
